## A RESOLUTION APPROVING THE PROPOSED DEVELOPMENT OF A CAMPUS SUSTAINABILITY UNIT OF WESTERN MINDANAO STATE UNIVERSITY

NOW, THEREFORE, upon motion and duly seconded, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the Board of Regents of Western Mindanao State University APPROVES the development of a Campus Sustainability Unit;
