A RESOLUTION APPROVING THE PROPOSED CHANGE OF NOMENCLATURE FROM COLLEGE OF PHYSICAL EDUCATION, RECREATION, AND SPORTS TO COLLEGE OF SPORTS SCIENCE AND PHYSICAL EDUCATION MARKED AS ANNEX "C"

WHEREAS, Dr. Ma. Blancaflor R. Jimeno, Dean of the College of Physical Education, Recreation and Sports (CPERS) presented to the Board the **Academic Council Resolution No. 2 Series 2021** (via Referendum) which states: Resolved, to approve the proposed change of nomenclature of the College of Physical Education, Recreation and Sports to College of Sports Science & Physical Education;

WHEREAS, The Board of Regents deliberated/discussed the **proposed change of nomenclature of the College of Physical Education, Recreation & Sports to College of Sports Science & Physical Education** as attached in **Annex "C"** of the Agenda Folder as part and parcel of this resolution;

WHEREAS, Dr. Jimeno reported that during the Accreditation Visit of the Accrediting Agency of Chartered Colleges and Universities in the Philippines, Inc. (AACCUP), it was recommended that the Programs offered may be aligned with the College Nomenclature and its Vision, Mission, Goals, and Objectives, Organizational Structure, and College Logo (Refer to **Annex "C"**);

WHEREAS, In order to boost and magnify the relevance of the College, it was proposed to metamorphose into something bigger and better to answer the call for global integration. Henceforth, it could be achieved if the WMSU College of Physical Education, Recreation and Sports will be renamed to **College of Sports Science and Physical Education**;

WHEREAS, Provided there's no additional courses in the curriculum but only to change the college nomenclature based on the existing Commission on Higher Education Memorandum Orders (CMOs) of the different programs that the college is offering, the Board of Regents approved for the change in nomenclature of the college be renamed as **College of Sports Science and Physical Education (CSSPE)** effective **2nd Semester, Academic Year 2020-2021**;

NOW THEREFORE, Upon motion of Regent Damhar K. Pahalawan and unanimously seconded, **BE IT RESOLVED AS IT IS HEREBY RESOLVED,** That the Board of Regents **APPROVES THE PROPOSED CHANGE OF NOMENCLATURE FROM COLLEGE OF PHYSICAL EDUCATION, RECREATION, AND SPORTS TO COLLEGE OF SPORTS SCIENCE AND PHYSICAL EDUCATION MARKED AS ANNEX "C".**
