A RESOLUTION APPROVING THE PROPOSED REVISION ON THE EXISTING MASTER OF SCIENCE IN PHYSICAL EDUCATION PROGRAM MAJOR IN SPORTS MARKED AS ANNEX "D"

WHEREAS, Dr. Ma. Blancaflor R. Jimeno, Dean of the College of Physical Education, Recreation and Sports (CPERS), presented to the Board the **Academic Council Resolution No. 3 Series 2021** (via Referendum) which states: Resolved, to approve the proposed revision on the existing Master of Science in Physical Education (MSPE) major in Sports Program (BOR No. 121, S. 2007);

WHEREAS, The Board of Regents deliberated/discussed the **proposed revision on the existing Masters of Science in Physical Education Program major in Sports** as attached in **Annex "D"** of the Agenda Folder as part and parcel of this resolution;

WHEREAS, Due to the transition of the undergraduate program in 2018, the College aimed to align the offering of Master of Science in Physical Education major in Sports Program (MSPE) to the Bachelor's Degree in Physical Education (CMO 80, S. 2017);

WHEREAS, Based on the Policies, Standards, and Guidelines for Master of Science Program (CMO No. 15, S. 2019), the MSPE is offered with at least thirty (30) units of coursework and six (6) units of thesis with a total of 36 units. Henceforth, the College of Physical Education, Recreation, and Sports proposed for the revision of the curriculum of the Master of Science in Physical Education major in Sports program from a **total number of 48 units to 36 units**;

WHEREAS, The **Summary of Academic Units** for **Master of Science in Physical Education (MSPE)** is provided hereunder;
