A RESOLUTION APPROVING THE LIFTING OF THE MORATORIUM ON THE COLLECTION OF UNIVERSITY STUDENT COUNCIL (USC) FEES AND APPROVING THE COLLECTION OF FEES IN THE COLLEGES SUBJECT TO THE CONSULTATION AMONG THE STUDENTS OF THE UNIVERSITY

WHEREAS, the Student Regent, Hon. Jerome Dominic G. Rabara, manifested to the Board of Regents the proposal of the University Student Council (USC) to start collecting fees in the different colleges to defray the expenses and allocate budget on the different projects that the USC has proposed;

WHEREAS, the University President Dr. Ma. Carla A. Ochotorena informed the Board of Regents that there is a moratorium on the collection of college fees from the students and she interposes no objection on the lifting of the moratorium;

WHEREAS, the Board of Regents deliberated and discussed the proposal of Student Regent Jerome Dominic G. Rabara on the resumption of the collection of fees from the students in the different colleges of the University, including those in the External Studies Units (ESU);

WHEREAS, the CHED-ROIX Regional Director Dr. Rody P. Garcia manifested that any collection of fees from the students shall undergo consultation;

WHEREAS, the Student Regent Jerome Dominic G. Rabara informed the Board of Regents that there are already signed resolutions from the USC Senate and House of Representatives on the approval to collect fees from the students in the different colleges and the requirement of consultation has already been complied with;

WHEREAS, as a corollary to this resolution, the Board of Regents directed the USC President to consult with the students regarding the collections of fees;
