- d. Master of Arts in Education in Language Teaching (English) to Master of Arts in English Language Teaching
- e. Master of Arts in Education in Language Teaching (Filipino) to Master of Arts in Filipino Language Teaching
- f. Master of Arts in Education major in Nutrition and Health Education to Master of Science in Nutrition and Dietetics
