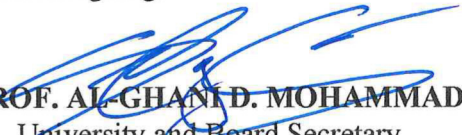
WHEREAS, the new composition of the Bids and Awards Committee (BAC) of the University will take effect on January 3, 2022;
