WHEREAS, a proposal has been presented to increase the incentives for topnotchers in board and bar examinations;

Yanga, **BE IT RESOLVED, AS IT IS HEREBY RESOLVED,** that the Board of Regents of Western Mindanao State University hereby approves the increase in the incentives of topnotchers in the board and bar examinations as follows:

- 1. Top 1 Php 100,000.00
- 2. Top 2 Php 50,000.00
- 3. Top 3 Php 25,000.00
- 4. The Rest of the Topnotchers Php 10,000.00

BE IT FURTHER RESOLVED, that these incentives shall be awarded to WMSU graduates who achieve the specified rankings in their respective board or bar examinations;

BE IT FURTHER RESOLVED, that the University Administration is hereby directed to implement this incentive program and to allocate the necessary funds in the University budget; Resolution No. 17, Series of 2025
