A RESOLUTION APPROVING THE RENAMING OF WMSU-ALICIA CAMPUS TO WMSU-ALICIA YASHIER S. MUSA, AL-HAJ CAMPUS

WHEREAS, Western Mindanao State University (WMSU) has established the WMSU-Alicia Campus in the Municipality of Alicia, Zamboanga Sibugay Province, to serve the educational needs of the local community and the surrounding municipalities;

WHEREAS, the University recognizes the significant contributions and distinguished leadership of Yashier S. Musa, Al-Haj, who had been a dedicated supporter and advocate of WMSU-Alicia Campus since its inception;

WHEREAS, Yashier S. Musa, Al-Haj, had actively participated in the campus development, championed various academic and community programs, and secured substantial funding and resources to enhance the campus's facilities and educational offerings;

WHEREAS, the Municipal Government of Alicia, in consultation with the local community and key stakeholders, has proposed to rename the WMSU-Alicia Campus to WMSU-Alicia Yashier S. Musa, Al-Haj Campus, as a fitting tribute to Yashier S. Musa, Al-Haj's remarkable contributions and to honor his lasting legacy in the municipality;

WHEREAS, the Board of Regents has carefully considered the proposal and finds it to be a well-deserved recognition of Yashier S. Musa, Al-Haj's exemplary service and commitment to WMSU-Alicia and the local community;

WHEREAS, the Board of Regents deliberated the "*Proposed Renaming of WMSU-Alicia Campus to WMSU-Alicia Yashier S. Musa, Al-Haj Campus*" as discussed in "*Annex J*" of the Agenda Folder with Attachments as part and parcel of this resolution;

Locson, **BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, that the Board of Regents of Western Mindanao State University hereby approves the renaming of the WMSU-Alicia Campus to WMSU-Alicia Yashier S. Musa, Al-Haj Campus;

BE IT FURTHER RESOLVED, that the University Administration is hereby directed to undertake the necessary actions and procedures to formally implement the name change, including the updating of all relevant documents, signage, and public communications;

BE IT FURTHER RESOLVED, that a formal dedication ceremony shall be organized to commemorate the renaming of the campus and to recognize the invaluable contributions of Yashier S. Musa, Al-Haj, to WMSU-Alicia Campus and the local community;

BE IT FINALLY RESOLVED, that this resolution shall take effect immediately upon its adoption.
