APPROVING FOR THE ADOPTION OF INCENTIVE FOR TECHNICAL REVIEWERS OF RESEARCH PROJECT PROPOSALS AND MANUSCRIPTS FOR PUBLICATION AS A POLICY ON RESEARCH AND EXTENSION SERVICES

WHEREAS, Board Resolution No. 42, s. 2021, dated March 01, 2021, provides that Dr. Teresita A. Narvaez, the Vice-President for Research, Extension Services, and External Linkages, presented to the Board of Regents the Proposed Policies on Research and Extension Services, as attached in Annex "J" of the Agenda Folder as part and parcel of this resolution;

WHEREAS, the Incentive for Technical Reviewers of Research Project Proposals and Manuscripts for Publication (ITRRPPMP) was highlighted as one of the proposed policies on Research and Extension services;

WHEREAS, the rationale of the ITRRPPMP Policy are as follows:

- Peer Review is a process for subjecting the scholarly work of researchers to the scrutiny of experts of the same field who determines the suitability of manuscripts for publication and quality of research proposals both in form and substance; and
- To attract more faculty and experts to be part of the university pool of reviewers, Two Thousand Pesos (PhP 2,000.00) per technical writer of every completed review will be incentivized.

**WHEREAS**, the incentivization of the technical review aims to achieve the following objectives:

- 1. Improve the quality of approved research projects by providing thorough and appropriate evaluation of the submitted proposals/manuscripts; and
- 2. Diversify the pool of technical reviewers which would allow the Office of the Research Development and Evaluation Center (RDEC) to review proposals/manuscripts across all disciplines as identified in the research agenda of the Western Mindanao State University.

**WHEREAS**, WMSU faculty and experts from other institutions and agencies may be tapped to be part of the pool of reviewers;
