RESOLUTION NO. 65

Series 2023 (By Referendum) June 23, 2023

A RESOLUTION AUTHORIZING THE UNIVERSITY TO PAY AN ANNIVESARY BONUS TO ALL QUALIFIED EMPLOYEES IN THE AMOUNT OF PHP 3,000.00 EACH

WHEREAS, the Western Mindanao State University (WMSU) has just celebrated its 45th anniversary as a university. On June 10, 1978, then President Ferdinand E. Marcos signed Presidential Decree No. 1427 converting Zamboanga State College to Western Mindanao State University:


WHEREAS, in line with the 45th anniversary celebration of WMSU as a university, the University Administration has proposed for the payment of anniversary bonus to all qualified employees in the amount of three thousand pesos (Php 3,000.00) each and with a total of one million eight hundred ninety thousand pesos (Php 1,890,000.00). The breakdown of qualified employees to receive the anniversary bonus is as follows:

WHEREAS, the payment of the anniversary bonus is in accordance with Administrative Order No. 263 dated March 28, 1996 and NBC No. 452 dated May 20, 1996. Also, pursuant to National Budget Memorandum (NBM) No. 142 dated January 12, 2022, or the National Budget Call for FY 2023, WMSU qualified for payment of anniversary bonus on the occasion of milestone year of signing of Presidential Decree No. 1427 on June 10, 1978;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that the Board of Regents hereby AUTHORIZES THE UNIVERSITY TO PAY AN ANNIVESARY BONUS TO ALL QUALIFIED EMPLOYEES IN THE AMOUNT OF PHP 3,000.00 EACH.
