A RESOLUTION APPROVING THE PROPOSED CHANGE OF OFFICE NAME FROM INTERFAITH CAMPUS MINISTRY CENTER TO MULTI-FAITH SERVICES OFFICE OF WESTERN MINDANAO STATE UNIVERSITY

WHEREAS, Western Mindanao State University (WMSU) recognizes the importance of fostering an inclusive environment that respects diverse religious and spiritual beliefs among its students, faculty, staff, and stakeholders;

WHEREAS, the existing Office known as the Interfaith Campus Ministry Center has served as a religious and spiritual support unit but requires a name that better reflects its evolving role in promoting inclusivity and multi-faith services across the University community;

WHEREAS, the proposed change of office name to **Multi-Faith Services Office** aims to better represent its broader scope of providing support, services, and programs across various faiths and belief systems;

WHEREAS, the proposal has been reviewed and endorsed by the Office of Student Affairs and relevant university committees, ensuring alignment with institutional vision and policies;

WHEREAS, the Board of Regents deliberated the "*Proposed Change of Office Name from Interfaith Campus Ministry Center to Multi-Faith Services Office*" as discussed in "*Annex R*" of the Agenda Folder with Attachments as part and parcel of this resolution;

NOW, THEREFORE, upon motion and duly seconded, **BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, that the Board of Regents of Western Mindanao State University **APPROVES** the proposed change of office name **Interfaith Campus Ministry Center** to **Multi-Faith Services Office**;
