BE IT FURTHER RESOLVED, that the degrees shall be conferred upon these candidates at the Commencement Exercises to be held on a specified date;

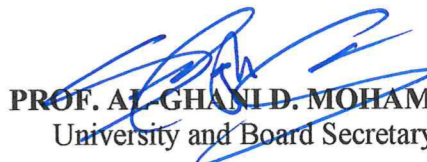
