A RESOLUTION APPROVING THE PROPOSED IMPLEMENTING GUIDELINES FOR GRANTING OF UNDERGRADUATE THESIS FINANCIAL ASSISTANCE

WHEREAS, the Vice-President for Research, Extension Services and External Linkages (VP-RESEL) Dr. Teresita A. Narvaez presented to the Board of Regents the proposed implementing guidelines for granting of undergraduate thesis financial assistance;

WHEREAS, the VP-RESEL Dr. Narvaez informed the Board of Regents that this proposal is in accordance with the provision of the University's Research and Development (R & D) Manual, which provides that deserving undergraduate students may receive financial assistance for their theses if they are in line with the University's priorities, thrusts, and programs, or if they are a part of the existing college's or unit's thrust and priorities;

WHEREAS, the VP-RESEL Dr. Narvaez also informed the Board of Regents that the maximum financial help for an undergraduate thesis is 10,000 pesos (Php 10,000.00) each study, subject to the University President's discretion. In circumstances when the required financial resources for studies, research, or development initiatives exceed the maximum amount mentioned below, the University President may, at her discretion, increase the maximum amount;

WHEREAS, the Board of Regents deliberated and discussed the proposed implementing guidelines for granting of undergraduate thesis financial assistance as attached in Annex "T" of the Agenda Folder as part and parcel of this resolution;

WHEREAS, as a corollary to this resolution, the Board of Regents directed the proponent VP-RESEL Dr. Teresita A. Narvaez to incorporate all the comments and suggestions of the Chairperson Comm. Aldrin A. Darilag, as well as those of Regents Adrian P. Semorlan, Martin A. Wee, and Phlorita A. Ridao in the proposed implementing guidelines for granting of undergraduate thesis financial assistance;
