A RESOLUTION APPROVING THE TRANSFER OF PROGRAMS, CHANGE OF NOMENCLATURE, AND REALIGNMENT OF CURRICULUM PER COMMISSION ON HIGHER EDUCATION MEMORANDUM ORDERS

WHEREAS, the Commission on Higher Education (CHED) has issued Memorandum Orders pertaining to the transfer of programs, change of nomenclature, and realignment of curriculum in higher education institutions;

WHEREAS, the Western Mindanao State University (WMSU) aims to comply with these CHED Memorandum Orders to ensure the quality and relevance of its academic offerings;

WHEREAS, the following programs have been proposed to be transferred, changed in nomenclature, and realigned:

- 1: Transfer of Graduate Programs from CSM to CTE Effective SY 2024-2025
 - a. Doctor of Philosophy in Science Education major in Biology
 - b. Master of Arts in Science Education
 - Master of Science in Mathematics Education
 - d. Master of Science in Teaching Biology
 - e. Master of Science in Teaching Physics
 - f. Master of Science in Teaching Chemistry
 - g. Master of Science in Teaching Mathematics
- 2: Change of Nomenclature from Master of Arts in Education major in Home Economics to Master of Arts in Home Economics Program of the College of Home Economics and Realignment of its Curriculum Effective SY 2025-2026
- 3: Realignment of Curriculum for Master of Science in Nutrition and Dietetics Program of the College of Home Economics Effective SY 2024-2025

Resolution No. 96, Series of 2024 3rd Quarter Regular Board Meeting October 3, 2024 WHEREAS, the Board of Regents has reviewed the proposed changes and finds them to be in the best interest of the institution and its students;

WHEREAS, the Board of Regents deliberated the "Transfer of Programs, Change of Nomenclature, and Realignment of Curriculum per Commission on Higher Education Memorandum Orders" as discussed in "Annex E" of the Agenda Folder with Attachments as part and parcel of this resolution;

NOW, THEREFORE, upon motion of Regent Adrain P. Semorlan and duly seconded by Regent Martin A. Wee, **BE IT RESOLVED AS IT IS HEREBY RESOLVED**, that the Board of Regents of Western Mindanao State University hereby approves the following actions:

1. Transfer of Programs:

- a. Doctor of Philosophy in Science Education major in Biology, from College of Science and Mathematics to College of Teacher Education
- b. Master of Arts in Science Education, from College of Science and Mathematics to College of Teacher Education
- c. Master of Science in Mathematics Education, from College of Science and Mathematics to College of Teacher Education
- d. Master of Science in Teaching Biology, from College of Science and Mathematics to College of Teacher Education
- e. Master of Science in Teaching Physics, from College of Science and Mathematics to College of Teacher Education
- f. Master of Science in Teaching Chemistry, from College of Science and Mathematics to College of Teacher Education
- g. Master of Science in Teaching Mathematics, from College of Science and Mathematics to College of Teacher Education

2. Change of Nomenclature:

a. Master of Arts in Education major in Home Economics to Master of Arts in Home Economics

3. Realignment of Curriculum:

- a. Master of Arts in Home Economics curriculum to be realigned according to CHED Memorandum Order No. 15, s. 2029, effective S.Y. 2025-2026
- b. Master of Science in Nutrition and Dietetics curriculum to be realigned according to CHED Memorandum Order No. 15, s. 2029, effective S.Y. 2024-2025

BE IT FURTHER RESOLVED, that the University President Dr. Ma. Carla A. Ochotorena or her designated representative is hereby authorized to implement these changes and to submit all necessary documentation to the CHED Regional Office IX for approval and compliance;

This resolution shall take effect immediately upon its adoption.
