A RESOLUTION CONFIRMING THE REVISION OF THE JURIS DOCTOR CURRICULUM WITH THE INTEGRATION OF CLINICAL LEGAL EDUCATION

WHEREAS, the Board of Regents discussed/deliberated on the Revision of Juris Doctor Curriculum with the Integration of Clinical Legal Education, as attached in Annex "W" of the Agenda Folder as part and parcel of this resolution;

WHEREAS, Atty. Jules Christian D. Marcos, the OIC Dean of the College of Law, presented to the Board of Regents the Revised Juris Doctor Curriculum which incorporates Clinical Legal Education I and Clinical Legal Education II which was duly approved through a Referendum as endorsed in the Academic Council Resolution No. 6, S. 2021;

WHEREAS, in compliance with the amendments to Rule 138-A of the Law Student Practice Rules of the Rules of Court and with the Legal Board Education Memorandum Order No. 23 (LEB 23) S. 2020, the proposed Juris Doctor Curriculum will be implemented on the First Semester of S.Y. 2021-2022;

WHEREAS, Clinical Legal Education I which corresponds to the first level CLE Certification shall be offered in the First and Second Semester of the Second Year JD Curriculum. Hence, students may enroll either in the First or Second Semester, at their option;

WHEREAS, Clinical Legal Education II will be offered in the Second Semester of the Third Year Curriculum;

**NOW THEREFORE**, upon motion of Regent Ricardo G. Garcia Sr. and duly seconded by Hon. Aba-a, Hon. Vicente P. Locson, and Hon. Edwin M. Caliolio, **BE IT RESOLVED AS IT IS HEREBY RESOLVED**, that the Board of Regents **CONFIRMS THE REVISION OF THE JURIS DOCTOR CURRICULUM WITH THE INTEGRATION OF CLINICAL LEGAL EDUCATION**.
